This training agreement is between Simply Southern Retrievers, LLC and

Type of training desired (circle): Gun Dog Obedience

Outlined below are the standard terms applicable to this training agreement.

1. Client agrees to vaccinate or have vaccinated his/her retriever for the following canine diseases before placement in Simply Southern Retrievers training program. Proof of fulfillment for the vaccination requirement via veterinary documentation is mandatory to this agreement. ____

Required: Rabies, Distemper/Parvo, and Bordetella

2. Client agrees to provide or to pay for the administration of monthly heartworm preventive and monthly flea and tick prevention. ____

3. Client agrees to cover any and all expenses related to emergency and or routine veterinary visits required for client's retriever while under the care of Simply Southern Retrievers. ____

4. Training fees are billed once per month at the beginning of each month. For gundog training, there is a minimum four months of training. Payment is expected and client agrees to comply with payment upon receipt of invoicing.

Client understands and agrees that training fees are on a "per month" basis. This means that while client's retriever is in training the client will be billed for the training month in its entirety regardless if the retriever is taken home for periods of time for whatever reason (except medical reasons). If client wishes to remove his/her retriever from the training program at Simply Southern Retrievers, LLC the removal must be done prior to the start of another training month. ____

5. Owner/agent agrees to provide any special care supplies (medication, special diet, supplements, Etc.) at their expense and authorizes the administration of said special care supplies.

Owner/agent agrees to pay for any ancillary products and services requested/required. ____

6. Owner/agent accepts responsibility for any damages the above named dog may cause through malicious, aggressive or improper behavior and will reimburse Simply Southern Retrievers in full for the value of those damages. ____

As the owner and/or caretaker of said dog, by signing below, you hereby provide to the Kennel Owner and Operator your consent to have said dog left unattended as provided in this form, and hold unaccountable for any unforeseen injuries/death that may occur.
